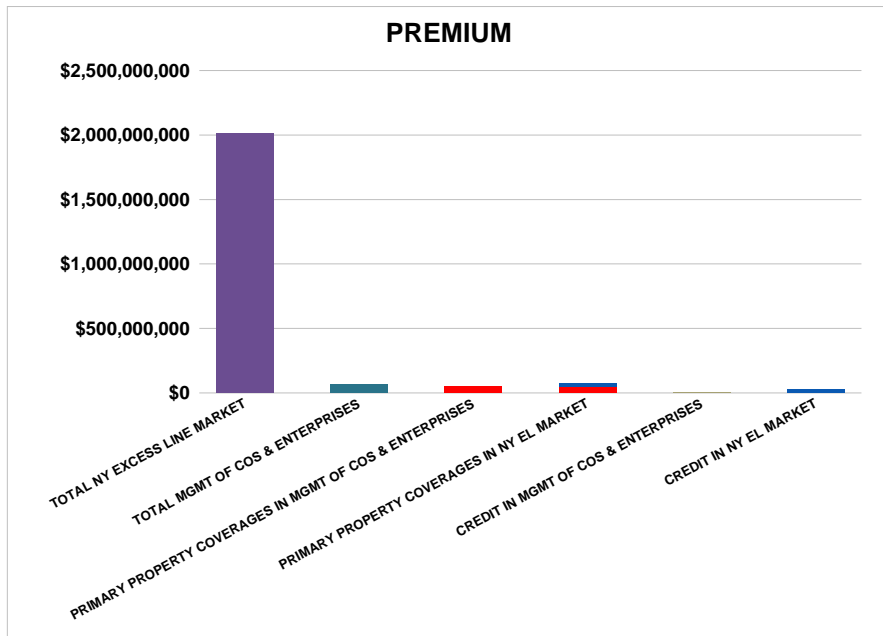

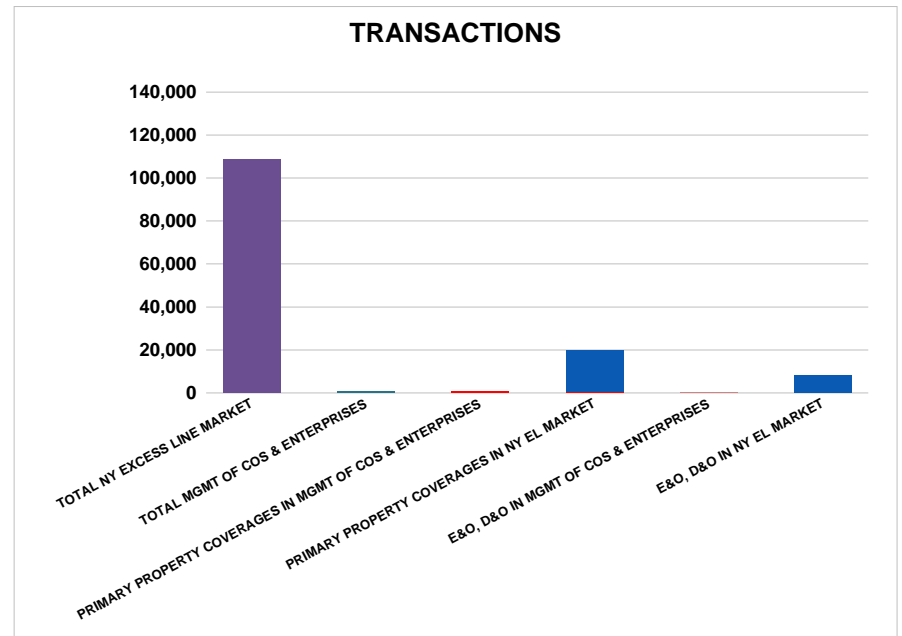
Management Of Companies And Enterprises Risk Transactions of **589** constituted **0.54%** of total YTD MARCH 2024 New York Excess Line Transactions.
