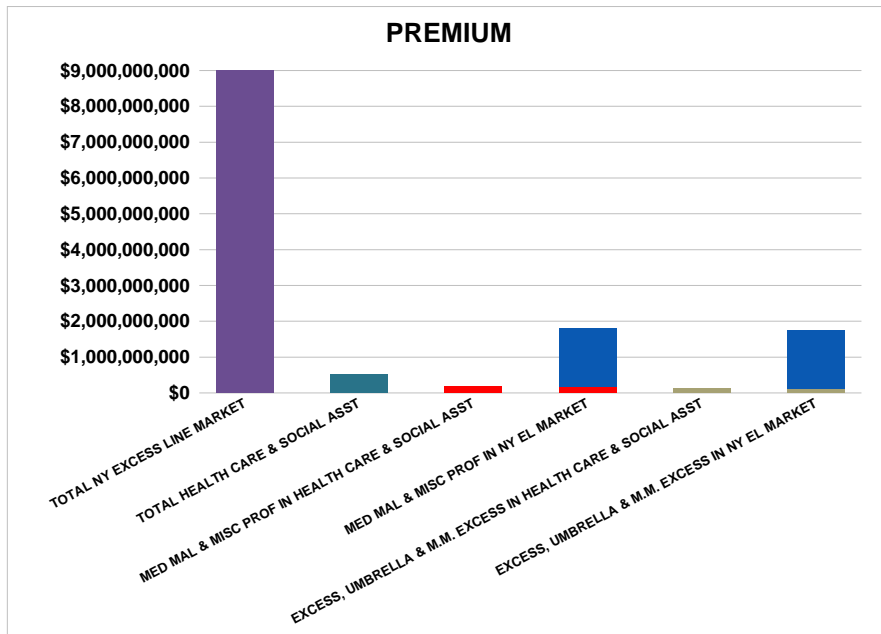

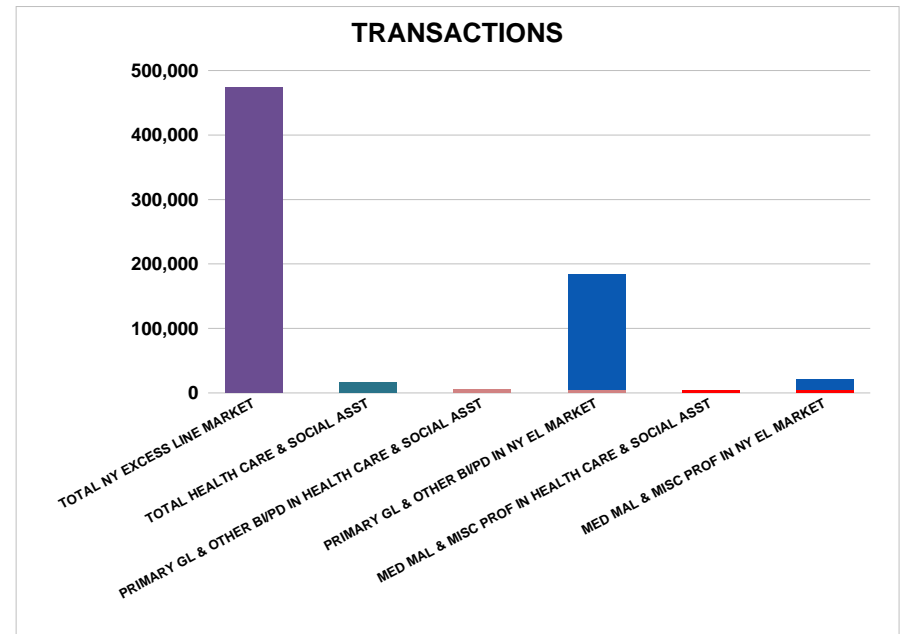
Health Care And Social Assistance Risk Transactions of **16,405** constituted **3.46%** of total 2024 New York Excess Line Transactions.
